This lecture will discuss the various procedures available to address flatfoot deformity in children as well as adults. Procedures such as subtalar arthroereisis, endoscopic gastroc recession, flexor digitorum tendon transfer and calcaneal osteotomies will be reviewed. Myerson classification of posterior tibial dysfunction will also be covered. The goal of this lecture is for the attendees to understand how to classify a flatfoot deformity and posterior tibial dysfunction. The objective is for the attendees to be able to address these deformities in their own practices and understand the benefits and alternatives when employing the surgical procedures discussed.

*Tarsal Tunnel Surgery for Neuropathy –*

This lecture will discuss various nerve decompressions utilized for the surgical treatment of neuropathy. The emphasis will be on diabetic neuropathy. Diagnostic modalities will be addressed as well as current research on the various surgeries discussed. The goal is for the attendees to understand and employ the procedures discussed when appropriate. The risks and benefits of the procedures will also be covered. The objective of the lecture is for the attendees to understand neuropathy and the surgical management of the disease when conservative measures fail.

Anatomy and biomechanics of the 1<sup>st</sup> mtpj will be covered as well as classifications currently employed. Cheilectomies, decompression osteotomies, arthrodesis and implants will be addressed with the indications and complications evaluated. The goal is for the attendees to better understand the indications of the various procedures available. The objective is for the podiatric surgeon to be able to choose the most appropriate procedure for the select patient..

Resurfacing hemiarthroplasty of the 1<sup>st</sup> mtpj will be addressed in this lecture. The concept of hemiarthroplasty as well as its evolution will be discussed. The goal of the talk is for the podiatric surgeon to understand the concept of hemi implants addressing the 1<sup>st</sup> metatarsal head vs the proximal phalanx base. The objective is for the attendees to be able to employ this technology for the proper indications. Application and instruction of the Encompass implant utilization will be discussed in detail.

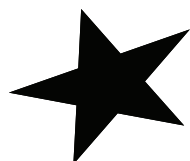

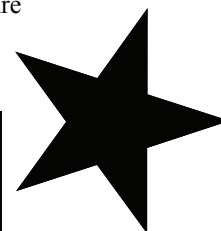
